Distinguishes between multi-speaker audio recordings

Speaker tone and pronunciation is carefully monitored to separate speakers' dialogues to avoid blocks of transcription that might otherwise require post transcription editing.

Colour coded transcription by speaker

Transcription output is quickly analysed and cross referenced to the original audio files, minimising downtime and maximising productivity. Keywords and phrases are also highlighted.

High processing rate

Time availability is critical; audio files are turned around in a few moments depending on volumes.
